ENGINEERS STORM THE STATE CAPITOL AGAIN

ASCE LEGISLATIVE AFFAIRS DAY "II" A SUCCESS!

You may recall that the the four Pennsylvania Sections of ASCE (Central PA, Lehigh Valley, Pittsburgh and Philadelphia) released the PA Infrastructure Report Card in 2006 and, as a follow-up, scheduled a day with legislators in May 2007. Based on the success of this event, it was repeated this year on May 13, 2008, with over 70 members of ASCE, the Pennsylvania Society of Professional Engineers (PSPE), the American Society of Highway Engineers (ASHE), and the Mid-Atlantic Section, Institute of Transportation Engineers (MASITE) in attendance.

The day began with some updates and pointers on discussion topics as well as addresses from **Reps. Joseph Markosek** and **Richard Geist** on the current funding solutions, including the Pennsylvania Turnpike leasing proposal. Following the opening session, teams met with over 75 Senators and Representatives to express our groups' concerns and positions on infrastructure funding and support of educational programs related to Science and Engineering.

PHILA. SECTION PARTICIPATES IN DELAWARE VALLEY SCIENCE FAIR ONCE AGAIN!

For the 15th consecutive year, the ASCE, Philadelphia Section sent judges to the Delaware Valley Science Fair, which was held on April 2 at the Valley Forge Convention Center. The Section's judges reviewed numerous projects and came up with two winners in each of the categories of Grades 6-8 and Grades 9-12.

The winning students and their projects were:

Grades 6-8 First Place — Joseph Kiernan, Haddonfield Friends School. Joseph's effort, As Solid As A Rock, looked into the strength of various concrete mixes. He is a 7th grader. (Joseph won the Section's Second Place prize last year with the project, A Bridge Over Troubled Water.)

Grades 6-8 Second Place — Billy Ransom, an 8th grader at Springer Middle School in Wilmington, took second place with 3D Shapes and Vertical Compression, an investigation on structural shapes.

Grades 9-12 First Place — Hannah Pilling, Springside School. Hannah, a 12th grade student, conducted her project on The Impact of Land Use in the Wissahickon Watershed on Stream Health.

Grades 9-12 Second Place — Benjamin Drake, a 10th grader at High Technology High School in Lincroft, New Jersey, presented his effort on Wave Breaking Buoys to look into coastal protection.

President James Markham attended the Fair's award ceremony on April 3 and presented commemorative plaques and checks to the winning students.

We were fortunate to have both First Place recipients in attendance at the Spring Social this year, and those of you who were there got to see the good work and effort that Hannah and Joseph put into their projects. More information on the Spring Social will be included in the October NEWS.

UPDATE ON PROFESSIONAL DEVELOPMENT REQUIREMENTS IN PENNSYLVANIA

As you may be aware (and as previously reported in THE NEWS), Senate Bill 655 was signed by Governor Rendell in November 2006. This means that Pennsylvania joins the list of states that will require continuing professional development (CPD) as a condition of license renewal. However, the exact mechanism of how this will be done and the regulations that will need to be effected by the State Board have not been developed, so the CPD requirement will not be in place for your next license renewal (October 2009) as planned. Thus, Pennsylvania PE's need not track CPD just yet, as it will not be needed for your next renewal, but will likely be in place for the following one (October 2011).

Additionally, another bill was introduced into the Legislature in February (Senate Bill 1264) on this subject. SB 1264 would have slightly different requirements and is more in line with those of neighboring states than SB 655 is, and it is more liberal in the allowance of what may be counted as CPD. SB 1264 has been referred to committee and public hearings may be scheduled. Our counterparts at the Pennsylvania Society of Professional Engineers (PSPE) are attempting to have at least one of these hearings scheduled in the Philadelphia area.

In any event, Pennsylvania has now taken two major steps forward in this area, and we will keep you posted on developments as they occur.

APRIL JOINT DINNER MEETING

Thursday, April 10, 2008

The Down Town Club, Center City Philadelphia **Developments at the Port of Philadelphia**

A "sellout" crowd of over 160 people wandered in from the streets of Center City on a nice spring evening and filled the main room at the Down Town Club to hear about the developments at the Port of Philadelphia. For the first time in recent memory, the turnout was such that we had to put some folks on "standby" mode to ensure that those who reserved would have spots over those who walked in. (And let that serve as a reminder — it's always a good idea to reserve a spot, since we cannot guarantee that walk-ins will be able to be accommodated!) This was our largest turnout in recent memory, even rivaling some of the joint meetings with ASHE that we've had that bring out lots of attendees.

The event was a collaboration of the Society of American Military Engineers, Philadelphia Post (SAME), the Pennsylvania Society of Professional Engineers, Philadelphia Chapter (PSPE), the Engineers' Club of Philadelphia (ECP) and our Section. Added into the mix were two colleges that were featured for the evening — Temple University and Widener University, each of which brought a sizable contingent of students. Additionally, the ASCE, Phila. Section celebrated its annual Past President's Night and about a dozen former Section Presidents were able to attend and be recognized.

The meeting was opened by ASCE, Phila. Section President James Markham, with an invocation by ECP President and Past Section President Ruben David. After dinner, President Markham returned to the podium to get the evening underway, with remarks from SAME Post President Rad Delaney and PSPE Chapter President Philip Udo-Inyang. Next up were the faculty advisors and Student Chapter representatives from each of the featured colleges. Temple's Student Chapter Faculty Advisor Bechara Abboud and Student Chapter President Caitlin Thomas updated all present on Temple's activities, followed by Widener's Student Chapter Faculty Advisor Vicki Brown and Student Chapter Representative Jeremy Paupuch.

Two Port Authorities

ECP President Ruben David came to update all on the Club's activities and introduced the evening's speaker, **John Estey**. Mr. Estey recognized and thanked those members of the Philadelphia Regional Port Authority (PRPA) staff in attendance and gave a little treatise on the two local port authorities. The Delaware River Port Authority (DRPA), on which he serves as the Governor's appointed chair, has more to do with the region's bridges and PATCO. PRPA, on the other hand, where he serves as chair, is more directly related to actual trade matters and port operations, and has evolved over the years from a City agency which operates port facilities to a State body.

Southport

Southport is the big item in the Port of Philadelphia at present, and it is a new site with exciting possibilities. Mr. Estey described the Southport site at the east end of the Navy Yard south of Packer Avenue Marine Terminal. The area is currently occupied by a rail yard and support facilities and is not fully utilized, as the Conrail ore/coal piers (Piers 122/124) have not been operating for several years. There is sufficient room for expansion of the Marine Terminal and related port facilities, and this is critical as this pier complex would additionally be able to accommodate large vessels that cannot clear the Walt Whitman Bridge.

Because of funding limitations from the usual public sources such as the State and the City, a public-private partnership (P3) is currently envisioned to get the project up and running in as little time as possible. Mr. Estey showed the rise in trade with China in particular over the past 15 years and how American and Canadian ports are not totally equipped to accommodate this surge. Water services are growing and carriers/operators want more direct control with their own terminals and operations. A major issue with West Coast ports is twofold — available berths and rail capacity issues for the so-called "land bridge." This is where P3's will be critically important.

Why does P3 offer the best solution for Southport? Mr. Estey noted that there is considerable economic development potential associated with it. The Port of Philadelphia is very competitive despite its distance from the ocean, and shipping/transloading costs are equal to what is experienced in New York and Baltimore. The now-available site, designated in a land swap several years ago, makes this development even more enticing.

Today, PRPA has projected costs of between \$250 million and \$430 million to build the desired complex and provide needed infrastructure. This is especially critical since there is no roadway connection to much of the site from the north, the primary means of access. Mr. Estey outlined the expected benefits of Southport, a total of 2800 port-related jobs, \$116 million in personal income, and \$25 million in tax revenues. There could be additional jobs created for "peripheral" activities that are not directly related to the expansion, such as trucking and railroad personnel.

How and When

Mr. Estey reviewed the in-place team of design/conceptual consultants that is working to put together an investment plan and engineering/ feasibility documents. The schedule is a very ambitious one, but this is necessary to make things happen especially given the current overseas trade situation.

The project timeline starts with the feasibility review, begun this past February. A market analysis is due in May. The request for qualifications (RFQ) process for conceptual design will begin in July, followed by requests for proposals (RFP) from potential facility operators in September. Mr. Estey reported that this ambitious schedule is expected to result in an agreement in place with an operator by February 2009. This concession agreement is expected to be for a term of 40-50 years.

Several thoughtful questions were asked by those present and ably answered by Mr. Estey, who was presented with tokens of appreciation for his presentation.
