# IT'S THE LAW! PROFESSIONAL DEVELOPMENT REQUIREMENTS

As you may be aware, Professional Engineers, Land Surveyors and Geologists in Pennsylvania are required to obtain continued professional development (CPD) credit to renew their licenses in 2011. This is effective as of October 1, 2009.

The State finally passed Act 25 in early May, which formalizes the continuing education requirement for licensure. Professional Engineers, Surveyors and Geologists will need to have 24 hours of professional development that is related to their professional practice in order to renew their licenses in October 2011. The Act will indeed cover the current licensure period (extending back to October 1, 2009), so any eligible coursework, etc. you may have amassed since then can be counted toward the current two-year period.

Additionally, there will be a six-month grace period (until April 2012) for license holders to obtain the required 24 PDH's if they have not already begun to do so or will not be able to acquire the full amount by the renewal date (October 2011).

After a somewhat confusing start and "flurry" of e-mails, the State Board has contacted all current PE's and supplied hard copy of the new requirements and related details. These are also available on the Department of State's website at **www.dos.state.pa.us/eng** for your information.

As you may be aware, New Jersey has also passed legislation on this and its program will become effective in early 2011. We will provide this information as it becomes available.

The Section's meeting program will be able to be counted toward your continuing education requirement and a verification program, including sign-in/attendance recording and "receipts," will be implemented this fall to help you obtain your PDH's.

## 25 Years of the Train to the Plane

On April 28, SEPTA's Airport Line service between Center City and Philadelphia International Airport marked 25 years of service. The Line opened on April 28, 1985 with operation between North Broad Station through the Center City Commuter Connection (which opened not quite six months earlier in November 1984) to the Airport. Seventy-three daily trains provided half hour service seven days per week between 6:00 AM and 12:30 AM.

It was initially planned to be part of the R1 Route from West Trenton, but service began independent of the West Trenton Line because of concerns about maintaining a high on-time performance. Projected to carry 1500 passengers initially, ridership reached 1900 trips shortly after opening. By comparison, the Airport Express Bus previously operated carried only about 335 passengers per day. In 1990 daily usage had grown to nearly 2500 trips.

Stations were added at University City (April 1995) and Eastwick (December 1997). The latter opened the line to use by commuters headed to newly-opened office space and hotels on the west side of the Airport along Bartram Avenue.

In 2010 the Line's average weekday rider count is 7500 trips.

While Philadelphia was not the first US city to have a rail line serve its Airport (Boston and Cleveland beat us to it), ours was the first to connect its regional rail/commuter system to its airport. For a short time in the late 80's and early 90's, Amtrak trains to and from Atlantic City also served the Airport terminals using this line. Since then, several cities have connected their rapid transit systems to their airports.

# **Nathan's Famous Hot Dog Eating** Contest

Every July 4th, there are fireworks everywhere. Fireworks of a different kind can be viewed in Brooklyn (and, through the miracle of television on ESPN), when the Nathan's Fourth of July Hot Dog Eating Contest gets underway.

At 12 Noon, a group of 20 steely-eyed individuals line up behind a 30-foot table at Nathan's flagship restaurant on Surf Avenue in Coney Island to begin the world hot dog eating championship, crushed by fans and media, for the historic 12-minute contest.

According to archives, the Contest was first held in 1916, the year Nathan's opened on Surf Avenue. The contest has been held each year since then, except in 1941, when it was canceled as a protest to the war in Europe, and in 1971, when it was canceled as a protest to civil unrest and the reign of free love.

# SECTIONS GRADE PENNSYLVANIA INFRASTRUCTURE

The four Pennsylvania Sections of ASCE (Central Pennsylvania, Lehigh Valley, Pittsburgh and us) joined forces earlier this year to assess the conditions of the state's infrastructure. The Sections reviewed data on twelve separate categories, including reports, studies, surveys and various other materials from professional societies and non-profit associations, as well as available information from government agencies at the local, state and federal levels. Based on this review, a detailed assessment of the condition of our infrastructure was developed, taking into account its performance, funding, capacity and future needs.

The Report Card is not meant to point out shortcomings in policy, performance and/or planning. It is not intended to be critical of efforts in areas that are admittedly difficult to manage and improve given constraints that are often beyond the control of those charged with the management and improvement of these facilities. Similarly, it is not designed to cite the failures of elected officials. It merely shows in an ataglance format where we are now and where we need to concentrate future resources, develop long-range financial and staffing plans, and anticipate measures which will preserve what we have so we can continue to use it rather than let it completely fail.

ASCE has undertaken this same effort on a national scale, and the Pennsylvania Sections decided to do their own for statewide conditions in 2006. This year's effort was an update of the previous one and included several new categories. In 2006, an overall grade of D was given — this year, no overall compilation was provided.

The Report Card was unveiled in a ceremony in the State Capitol at 8:00 AM on May 24 in conjunction with the fourth annual Legislative Day (see the related article below) and at local events around the state later in the day. It "grades" twelve specific areas of infrastructure conditions, as follows:

Even where the grade has not changed (for example, Bridges), while much has been done to address conditions, facilities continue to age and resources have not been available to do much more than to play "catch-up." While recent stimulus funding measures at the federal level were a much-needed "shot in the arm" to get things going, these are an example of a one-time program in an area in which the better solution is a long-range plan and identified, dedicated funding sources. In Pennsylvania the concentration of stimulus funds was strongly on bridges, where needs are great and many projects

were in a ready-to-go stage. Roads and Transit in particular have dropped in grade and this reflects one specific area of concern funding-wise.

Here in Philadelphia, the Section unveiled the Report Card at a ceremony at Dilworth Plaza on the west side of City Hall at 12 Noon, with local media outlets providing coverage and close to 200 attendees there to get copies of the Report Card in bright-red tote bags. We thank all those who attended and support the improvement of our infrastructure.

## ...And Legislative Day Held in Harrisburg

For the fourth year in a row, ASCE, along with the Pennsylvania Society of Professional Engineers (PSPE), the American Council of Engineering Companies (ACEC) and others, conducted its annual Legislative Day on May 24. Over 80 attendees from around the state participated and visited over 100 legislators to discuss the Report Card and, specifically, transportation funding needs.

With the prospect of reduced funding for roads, bridges, mass transit, and other transportation components, in spite of the growing needs, and no new resources in sight, our voices need to be heard, both as engineers and state residents. Transportation is an issue that affects all of us in some fashion.

We encourage you to contact your elected representatives to express the importance of continued long-range transportation and infrastructure funding.
