On October 17, 1912, twelve men met to formulate the plans of what was to become the Philadelphia Section of the American Society of Civil Engineers. Their primary objective was "... to promote closer professional and social contact among its members and to further the aims of the Society...". The plans for the ASCE, Philadelphia Section were submitted to ASCE and the National Board of Directors approved, resulting in the official creation of our Section on June 14, 1913.

At the time of our formation, things were a little different. Most communication was in the written form - radio was in its infancy and not available to most people (commercial radio would get its very limited start eight years later), and telegraph/telegrams were the only other means of communication. Movies were around but were silent. Telephones were just getting started and not all that common. Electric power was mainly a city/built-up area thing and was rare in rural areas (and would remain that way until the late 1930's). Transportation was on the ground, and mainly by rail, and slow, but the option by water was even slower. (And keep in mind you could sail coast to coast in the US, but it was by way of Tierra del Fuego in South America, since the under-construction Panama Canal would not open for another two years.)

As we trotted out at the end of last season, we have a new logo to cite our centennial (above), and will have several special events and happenings during the season to highlight this as well. In the Meeting Schedule provided elsewhere in this issue, you will note that we have already set the date for our **100th Anniversary Spring Social – Saturday, May 4, 2013** – at the **Franklin Institute**. Coming editions of *THE NEWS* will have some historical perspectives and notable events that have occurred in our 100 years for your reading pleasure.

JOHN W. (JACK) BOORSE

Longtime ASCE, Philadelphia Section Member **Jack Boorse** passed away on May 9 after a short illness. Mr. Boorse had served as principal professional associate for Transport Engineering in the Philadelphia office of Parsons Brinckerhoff (PB) since 1988 and was in this position at the time of his passing. Before his 24-year "second" career at PB, he had served the City of Philadelphia Department of Streets for 31 years as a traffic engineer, the last five years of which he had been the Department's Chief Traffic Engineer, before retiring in 1988.

Mr. Boorse was a founding member and chairman of the Philadelphia Traffic and Transit Coordinating Committee, which instituted dedicated traffic lanes for SEPTA's trolley lines. He also installed the first "trolleyonly" traffic bar signal in the United States.

As a consultant, Mr. Boorse was responsible for the integration of automobile traffic and light rail trains for 12 light rail systems operating today. He was an emeritus member of the Transportation Research Board (TRB) Committee on Light Rail Transit and the founding chair of its Subcommittee on Light Rail Circulator Systems. He published numerous papers in TRB journals and was a frequent contributor to Transit Cooperative Research Program reports. He was the author of two books, "Rapid Transit in Canada" (1968) and "Philadelphia in Motion" (1976). He is survived by his wife Penny and son Michael.

STORMWATER CONFERENCE - VILLANOVA

ANALYSIS OF WATER SURFACE PROFILES USING HEC-RAS

AUGUST 20-22, 2012

This course has been designed to familiarize engineers with the theoretical and practical aspects of HEC-RAS, the steady water surface profile model developed by the Hydrologic Engineering Center of the U.S. Army Corps of Engineers.

The course starts with a review of open channel hydraulics. After each new aspect of HEC-RAS is introduced, students will be given a design problem to analyze on the computer under supervision of the course instructors. Students will use the most current version of the package on microcomputers in Villanova's Computer Aided Classrooms. These facilities allow the instructors to present HEC-RAS results in a realtime environment. Specialized topics to be discussed include Cross Section Selection, Mixed Flow Regime Modeling, Bridge and Culvert Hydraulics, Floodway Determination, and Error Analysis. Theory and practical usage will be integrated to maximize understanding of HEC-RAS applications to real world design problems.

Lead Instructor: Robert G. Traver, Ph.D.,PE, D.WRE, Professor

Each instructor has extensive consulting, research, and academic experience with hydraulic models. Villanova participated as a Beta test site for HEC-RAS.

What you get: Each course participant will be shown how to download HEC-RAS, and will received the program documentation, a binder with the course lecture notes, and a PDH certificate for the course.

Course specifics: Registration will begin on August 20 at 8:30 AM at the College of Engineering MDL lab. The class will finish on August 22 by 1:00 PM.

A reception will be held at the end of class Monday. To improve the experience this year we are asking the participants to bring their own laptops. We have a limited number of laptops available for loan. Please contract Dr. Traver if you can not bring your own.

The fee for the conference is \$1100 prior to August 6, and \$1250 after that date. Group discounts are available. Current Villanova Civil Engineering Graduate students and VUSP partners are eligible to receive an additional discount. Enrollment is limited.

INFRASTRUCTURE (NEE LEGISLATIVE) DAY

For the sixth consecutive year, ASCE members statewide participated in the annual visit to our state's lawmakers in Harrisburg. This year, the event formerly known as Legislative Day switched names to better reflect its purpose, being christened Infrastructure Day, and it was held on May 8. Over 100 appointments were scheduled with legislators and nearly 70 participants from various organizations such as the Pennsylvania Society of Professional Engineers (PSPE), the American Council of Engineering Companies (ACEC), the American Society of Highway Engineers (ASHE), the American Public Works Association (APWA), and the Institute of Transportation Engineers (ITE), along with ASCE, were there to press the issue of our state's transportation funding needs.

With the prospect of reduced funding for roads, bridges, mass transit, and other transportation components, in spite of the growing needs, and no new resources in sight, our voices need to be heard, both as engineers and state residents. Transportation is an issue that affects all of us in some fashion.

A joint effort between the Engineers' Club of Philadelphia and our Section on May 14 brought Representative Allyson Schwartz and State Senator Michael Stack to the podium at Drexel University to speak on the subject of transportation infrastructure and funding. A crowd of roughly 100 attendees came to hear some promising news and ask both elected representatives for help to get more funding for the needs in this area.
