Mr. Helmer will outline evolving considerations that continue to raise the bar for Civil Engineers. PRESIDENT'S MESSAGE

Every year around this time, we have the opportunity to remind our elected officials of the importance of our infrastructure. In a few short days, we can use our voice, our collective voice as Civil Engineers and designers of the built environment to remind our officials of the critical condition of our infrastructure.

Every year in Pennsylvania, 300 bridges are added to the structurally deficient list. However, just 200 bridges are funded for replacement. In 2011, there were 954 reported broken water mains in the City of Philadelphia. Each year, approximately 11 of the 3,200 miles of water main in the city are replaced — with a 100 year design life.

It is our obligation to inform our elected officials as to the importance of clean water on public health, remind them of the value of a reliable power grid for business, and highlight the necessity of a suitable highway system for commerce. It appears that our elected officials have lost sight of those facts. It is our obligation, as the experts, to make our elected officials aware.

With that, I challenge our members to reach out with your votes. But don't stop there. Discuss with your parents and grandparents; kids and grandkids; nieces and nephews; aunts, uncles and cousins; friends and neighbors. With this outreach over the next few days, you can see how the influence of our 2,200 members can grow quickly.

Investing in our infrastructure creates jobs today, secures our children's future, and allows for economic growth as a City and Region. This is not a Republican issue or a Democratic issue. This is our issue. We need to exercise our collective voice and cast our votes on November 6.

PLEASE REMEMBER TO VOTE!

As none of us can escape, the reality is that election season is in high gear. We are hopeful that when the "hoopla" is over and we know who our leaders will be for the next terms, we can begin to work with them to impress the importance of what we as Engineers do and how our representatives can help us do more and better.

ASCE NATIONAL ITEMS OF INTEREST

ASCE ISSUES NEW "FAILURE TO ACT" REPORT ON AIRPORTS, MARINE PORTS, & INLAND WATERWAYS

ASCE released its latest "Failure to Act" report on the economic impact of underinvestment in America's infrastructure. In the report ASCE has projected a significant gap between planned investment and spending needs for the nation's airports, marine ports, and inland waterways. With ports and inland waterways critical to our nation's global competitiveness, ASCE's report forecasts investment falling \$16 billion short of the \$30 billion needed through 2020. For airports, ASCE projects a gap of \$19 billion from a total need of \$114 billion. Failing to meet the gaps creates a drag on the economy by causing congestion and delays for U.S. businesses that import and export goods, leading to higher transportation costs and causing the price of goods to rise.

The fourth report in the Failure to Act series was released during two events in Washington, D.C., one for media members and another for Congressional staff. Both events were moderated by ASCE President Andy Herrmann, and joined by Virginia Port Authority Executive Director Jerry Bridges, and Rick Calhoun, President of Cargo Carriers. The event on Capitol Hill was highlighted by remarks from Congresswoman Janice Hahn, co-chair and founder of the Ports Caucus.

OCTOBER DINNER MEETING

I-95 CPR

The first meeting of our centennial anniversary season was notable in several ways. First off, the weather was very nice, warm for an early fall day and evening, and the clear skies contributed to the great views from the 33rd Floor of the Loews Hotel, high atop Center City. Over 100 attendees gathered to enjoy the views from the bar during the cocktail hour, network, and partake of good food and an informative and entertaining presentation on a project that could be seen from the meeting room, if one looked hard enough.

Our ASCE, Philadelphia Section's Younger Member Forum (YMF) took the lead and arranged the presentation on the I-95 CPR project. While CPR is not what you probably first thought of when you read it, it is indeed the revitalization of one of our region's major highways, but the letters stand for "Cottman-Princeton Reconstruction." The focus of the work is primarily two-fold — the rebuilding of I-95 in the area of the Cottman Avenue (PA 73) interchange and the reworking of the virtual spaghetti strands of entrance and exit ramps, with the end result that traffic which flows in several directions through an adjacent residential neighborhood (because of the existing ramp pattern) will be redirected onto new ramps that will directly connect with the desired arterial roadways.

After the cocktail hour, attendees were coaxed to leave the open bar and move to the main hall for dinner and the presentation. President **Jeremy Colello** welcomed all and brought Past President **Ruben David** to the podium for his usual good blessing of the meal. As dinner wound down, President Colello returned to "front and center" to make a few short announcements and then welcome YMF President **Kazi Hassan**, who introduced the evening's speaker, **John Eagan**, Vice President of Alfred Benesch & Company and Project Manager for the I-95 CPR program.

The CPR project is one element of a larger effort focused on the reconstruction of I-95 in the Northeast Philadelphia area, from the Vine Street/I-676 interchange to the Cottman Avenue interchange. Mr. Eagan reported that CPR has been in design since 2000 and has two construction phases, each of which is now underway. The first phase has a construction value of \$32 million and concentrates on utility relocations, new ramp alignment construction, and local street improvements including sidewalk bumpouts and traffic calming measures. The second phase, worth \$245 million (and the largest project let to date by PennDOT, the owner), includes the I-95 structural widening needed to provide four through lines directional on the mainline (removing the current lane drop through the interchange).

The project, as Mr. Eagan explained it, was designed to mitigate the impact of the ramps on the neighborhood which encompasses the interchange, taking advantage of the need to

renew the infrastructure to re-examine the "disconnected" ramp situation provided with the original construction of I-95 in the early 1960's. The diversion of some of the ramps to the intended destinations, and not guiding through traffic through residential streets, would allow the return of these residential streets to local traffic and residents and provide a benefit to motorists who would no longer have to navigate these streets to get to and from the interstate highway.

President Colello thanked Mr. Eagan for his insightful presentation and gave him a token of the Section's appreciation (which, full of water and accompanied by two aspirins, would hopefully help Mr. Eagan's head cold!).

The second case study will provide an in-depth overview of the *Centennial District Transportation Center* at the *Philadelphia Zoo*, which is currently under construction. This 700-space parking facility and the enhanced traffic patterns associated with the development were designed to improve the notoriously-congested circulation issues spurring from the adjacent I-76 and its Girard Avenue interchange while providing necessary parking for Zoo patrons.

Both case studies demonstrate a high level of innovation and creativity that are exemplary for fostering successful community revitalization.

HAPPY 100TH BIRTHDAY, TRAFFIC SIGNALS...

And now you can't get the "Happy Birthday" song out of your head... (You're welcome!) Anyhow, like our ASCE, Phila. Section, another item that many of us are very familiar with is turning 100 this year – the traffic signal.

Pedestrians, horses, trolleys — and a growing fleet of automobiles — clogged early 20th Century streets in America. Travel was slow, navigation dangerous, and traffic cops stood amid the chaos at their own peril.

Enter Lester Farnsworth Wire, the dean of Salt Lake City's inaugural traffic squad and arguably the inventor of the world's first electric traffic light in 1912 - a birdhouse-like box with red and green bulbs on each side to signal stop and go to travelers. Wire is one of several men who lay claim to the title "Stoplight Inventor," but Utah celebrated the 100th anniversary of his creation on October 4 with a new display that includes a replica of the original signal.

So how progressive was Wire in 1912? There were plenty of skeptics, but it became a success, and signals are everywhere 100 years later, regulating and assisting traffic movement. Wire built a wooden box resembling a birdhouse and installed two bulbs on each side — one bulb dipped in green paint, the other dipped in red paint. The box sat in the middle of the intersection and, once connected to a nearby power source (overhead trolley wires), enabled police officers from the side to flip a switch and direct traffic. The creation came to be known as "Wire's Bird Cage" and "Wire's Pigeon House."

However, as early as 1868, a device with an arm that extended horizontally signaled stop and, when at a 45-degree angle, caution. And in 1914, a system in Cleveland, Ohio included four pairs of red and green lights, each mounted on a corner post and manually operated by a switch inside a control booth. That system was patented in 1918 by James Hoge. Thus, there is some controversy about whether Wire's invention was indeed the first traffic signal. In any event, Wire's "bird cage" is 100 years old this year.

THE SUBWAY MAP THAT RATTLED NEW YORKERS

And, forty years ago this past August, no sooner had the Metropolitan Transportation Authority introduced a new map of the New York subway system that complaints flooded in. Many stations seemed to be in the wrong places. The water surrounding the city was colored beige, not blue. As for Central Park, it appeared to be almost square, rather than an elongated rectangle, three times bigger than the map suggested, and was depicted in a dreary shade of gray.

The map was, indeed, riddled with anomalies, but that was the point. Its designer, Massimo Vignelli, had sacrificed geographical accuracy for clarity by reinterpreting New York's tangled labyrinth of subway lines as a neat diagram. Each station was shown as a dot and linked to its neighbors by color-coded routes running at 45-or 90-degree angles. Vignelli had used his design skills to tidy up reality.

Design buffs have always loved his map for its rigor and ingenuity. When the future graphic designer Michael Bierut made his first trip to New York in 1976, he took one home to Ohio as a souvenir. But many New Yorkers were outraged by what they saw as the misrepresentation of their city, while tourists struggled to relate Vignelli's design to what they found above ground. In 1979, the MTA bowed to public pressure by replacing his diagrammatic map with a geographical one.

The MTA had introduced one of four maps designed by Vignelli in1972 with the intention that, collectively, they would give passengers all the information they needed to navigate the subway. The diagrammatic System Map demonstrated how to get from A to B, but it was to be accompanied in each station by two Geographical Maps, one of the entire network and another of the local neighborhood, and a Verbal Map that explained in words how to go from place to place. Vignelli had never envisioned that the System Map would be used by itself.

Vignelli had modeled his System Map on the hugely popular 1933 diagrammatic map of the London Underground designed by Harry Beck, a freelance draftsman who compiled it in his spare time. Beck's "diagram," as he called it, applied similar organizational principles, arguably with even greater rigor. Unlike him, Vignelli had included some geographical references, by identifying Central Park and areas like Manhattan and the Bronx. He has since regretted doing so, arguing that the map should have been wholly abstract, devoid of such distractions. But Beck's design was gentler in style, particularly in its choice of typography, while Vignelli used a modern font, Helvetica.

The response to each map also reflected the architectural character of its city. London is such a huge, sprawling historical muddle that its citizens are generally relieved to see it simplified in Beck's "diagram" and cheerfully forgive him for misrepresenting the wonky River Thames as being straight and Angel station as being level with Old Street, when it is further north. Whereas New Yorkers pride themselves on knowing their way around the orderly geometric grid of their streets, which explains why many of them felt they had nothing to gain from a shrunken Central Park and oddly located stations.

Even so, Vignelli had the last laugh. Last year, the MTA introduced "The Weekender," an interactive version of the subway map on its Web site, and commissioned him to reinterpret his 1972 design for it. He did so on condition that it was described as a "diagram," not a map, and the parks were erased, Central Park included.

100TH ANNIVERSARY HISTORICAL PERSPECTIVE

In keeping with our 100th Anniversary celebration, we promised to provide some historical references, snippets, trivia and odd facts during this season for your reading enjoyment and to show what we've done over the past one hundred years that we've been around. Here are some for November:

1925

Plans were finalized for the 56th Annual ASCE Convention to be conducted in Philadelphia in 1926 in conjunction with the Sesquicentennial Exposition, marking the 150th anniversary of American independence. The Convention would be held at the Bellevue Stratford Hotel. Section Past President Richard L. Humphrey served as Chair.

1952

A Civil Defense Committee formed by the Section in November 1950 at the suggestion of National, submitted its reports on Center City to Mayor Joseph Clark. Eighty members surveyed 150 blocks. Mayor Clark presented a certificate of award to the Section in January 1953 in appreciation of this volunteer effort.

1957

The Section formed the Women's Auxiliary "to further social contacts among its members." The Auxiliary disbanded in 1989, a sign of changing times both in terms of the rising percentage of women in Section membership and the increasing number of women in the workplace.

1986

THE NEWS was printed for the first time using a new-fangled device called a "laser printer". Prior to this, it was produced via the typesetting process that dated back to the days of the Gutenberg printing press. The change in technology allowed revisions in format and photos became easier to include. (So why aren't there more?)
