### FEBRUARY MEETING

February 10, 1976 Engineers' Club

(Editor's Note: THE NEWS is indebted to Harold D. Gilman, Secretary-Treasurer of the Hydraulics & Sanitary Group for the authorship of the following article. See brief profile of Mr. Gilman elsewhere in this issue.)

Sponsor of the February Section meeting was the Hydraulics and Sanitary Engineering Group and Chairman Carl M. Koch was our able Program Host. Guest speaker was Fred E. Parkinson, Vice President and Development Manager, LaSalle Hydraulic Laboratory of LaSalle (Quebec) Canada. He spoke on "Physical Hydraulic Models."

### Temple Featured

The evening was also highlighted as "Temple University Night", with a significant presence of students and faculty from the School of Engineering Technology. Temple University now has a Student Club of the ASCE. Dean John L. Rumpf briefly summarized new programs, and introduced faculty, students and alumni present.

### Slides Illustrate Talk

Mr. Parkinson began his talk with some historical background, citing that physical hydraulic modeling is about 100 years old. The technology was initiated with a publication by Froude in 1870, and further advanced in 1885 with publications by Reynolds.

The basis of Mr. Parkinson's presentation is a collection of slides spanning 20 years. The slides were accompanied by a most interesting, highly personalized and informal description from our speaker. His discussion of hydraulic models covered such diverse applications as hydro-electric power, movable river beds, navigation, pollution dispersion, wave energy in ship channels, and ice studies. While most of the studies pertained to locations in Canada, the laboratory's models found applications in West Pakistan, France, Dahomey and San Juan.

The major effort at the LaSalle Laboratory, according to Mr. Parkinson, has been in modeling and designing hydroelectric dams and spillways. The modeling studies were especially effective in developing a unique arrangement for "closing the river", i.e. completing the last section of a dam.

Another unique application was the locating of an outfall for a fish canning factory on the Bay of Gaspe. As cited on the slides, the bay region was physically modeled, including local streams.

The constraints on the outfall demanded that no pollutants were permitted in the streams through long range operation. Many outfall locations were tested in the model and its simulated stream and tidal flows. With the selected outfall, an equilibrium condition was realized within 40 tides, and still no significant pollution in the streams.

Mr. Parkinson referred humorously to his work as "essentially a cut-andtry game which improves with experience," and compared it to 'beach play 52 weeks a year." The diversity, magnitude and precision of the models shown on the slides belied the simplistic statement, and gave strong testimony of a significant, deeply-rooted technology where computerized mathematical modeling has a long way to go to catch

The audience's interest was clearly evidenced by the size of the attendance, and the quality and variety of questions posed to Mr. Parkinson during the lengthy discussion session. Program host, Carl Koch, Chairman of the Hydraulics and Sanitary Engineering Group merits a congratulatory applause for having brought to the meeting our Canadian guest and his unique topic.

President Robert M. Koerner presented Mr. Parkinson a Certificate of Appreciation at the conclusion of the meeting.

#### UPDATE

Most of the bills we have been following are in committee. The Pennsylvania Flood Disaster Prevention Act, Senate Bill SB1, is continuing to run into opposition in the Joint House/Senate Conference Committee.

The Board of Directors of the Central Pennsylvania Section of ASCE has formally passed a resolution recommending that the "Pa. Flood Disaster Prevention Act" receive favorable action on the part of the Legislature of the Commonwealth and that the Legislature be informed of ASCE's backing of SB1. This information was transmitted to us recently by Guy Page, Chairman of the Central Pennsylvania Land Use Committee. The resolution cites the following reasons for ASCE favoring the Flood Plain Act: (1) recurrent flooding which causes severe suffering and economic loss; (2) unsuitable and unregulated construction in the flood plains which intensifies such suffering and economic loss; (3) the Act would provide a program of sensible and coordinated flood plain management; (4) the civil engineering profession has traditionally, and by virtue

# ASSOCIATE MEMBER FORUM NEWS

Traffic Surveillance System

The New Jersey Turnpike Authority has installed an automated traffic surveillance system that will increase highway capacity, improve safety conditions and possibly decrease future need for turnpike construction.

The system consists of 780 magnetic sensors installed beneath the pavement at half-mile intervals which convey information to two computers to light up arrows on display boards at state police and turnpike authority headquarters. The system continuously measures traffic density and can reroute traffic onto alternate roadways when there is serious congestion. The system will cost \$5 million and will automatically set speed limits according to traffic density.

The system is highly innovative and should effectively improve conditions on the nation's most heavily travelled corridor.

#### UMTA

Senator Harrison Williams of New Jersey is becoming Congress' most outspoken leader in public transit matters. He recently made it known that he is upset with the administrators of the Urban Mass Transportation Administration (UMTA). He cites, UMTA's recent rejections of applications for major capital grants such as the proposed rapid transit line in northern New Jersey and the light rail project in Dayton, Ohio. To date, there has been no response from Transportation Secretary William T. Coleman, Jr. concerning charges of "bureaucratic delays, red tape and endless paper pushing" on the part of UMTA,
