John F. Kennedy Airport. In addition to Mr. Cohen's current restoration work at the Statue of Liberty, he is involved in improvements to the West Front of the United States Capitol, the (Tweed) Courthouse in New York City and the oldest Roebling designed bridge which carried the Delaware Aqueduct over the Delaware River at Lackawaxen. Other current projects under Mr. Cohen's general responsibility include the renovation of the Golden Gate and Williamsburg Bridges, the Performing Arts Center for the University of West Virginia, a new Terminal for Dulles Airport, and United States Embassy security improvements.

As awardee of numerous prizes including the State-of-the-Art Civil Engineering Award in 1974 and Robert Ridgeway Award in 1946, Mr. Cohen is a Fellow of the American Society of Civil Engineers and the American Consulting Engineers Council. He is also an Honorary Member of the American Academy of Sciences and the American Concrete Institute. He has been a consultant to the RAND Corporation, Hudson Institute and other civilian and governmental agencies, and a Lecturer in Architecture at Columbia University.

# 1986 Daniel W. Mead CONTEST

#### FOR YOUNGER MEMBERS

The Daniel W. Mead Prize for Younger Members was established in 1939 to honor the memory and accomplishments of the 67th President of the American Society of Civil Engineers. The talents of many of the leaders of the profession were first recognized in previous contests for this significant professional honor. The current contest provides another opportunity for alert young civil engineers to further their professional development and gain national attention.

#### Rules

- \* Papers must be written on: "CAN CIVIL ENGINEERS 'MAKE THE DIFFERENCE" BY INVOLVEMENT IN THE POLITICAL PROCESS?"
- \* The civil engineering profession is continually being governed by new regulations written by political bodies. Many important issues that affect the public works for which civil engineers are responsible are being decided after public debate.
- \* Many design constraints that engineers are faced with in the areas of wastewater treatment, water quality, drainage and highway design have been dictated by elected officials following appeal by special interest groups.
- \* Should engineers take a more active role in the public debate? Would we be compromising our professional standing in the community if we do so or are we obligated to actively participate in these public discussions?
- \* How can civil engineers insure decisions are made based on a full open discussion of the technical issues involved, yet at the same time maintain our objectivity that enables us to implement the mandates of the elected officials.
- \* Authors must be Associate Members or Members of the Society 32 years of age or less on February 1, in the year of the award.
- \* Only one person can write each paper.
- \* Each Section can submit only one paper.
- \* Papers must contain no more than 2,000 words.
- \* One winner will be selected from each of the Society's four zones.
- \* The national winner, selected from the zone winners, will receive a wall plaque and a certificate.

The paper contest followed for the remainder of the morning. papers were presented by students from Drexel University, Lafayette College, Lehigh University, Swarthmore College and the University of Pennsylvania. Papers were presented in two categories: Group A, Investigative or Laboratory Research and Group B. General Research. The students were allowed fifteen minutes for their presentations, followed by a brief question and answer period. Following the morning paper contest, the Conference luncheon was held at the University of Pennsylvania Faculty Club. Ms. Lau introduced the faculty members in attendance from the University of Pennsylvania, the judges, distinguished members of the American Society of Civil Engineers and the Conference speaker, Mr. Vincent Kling.

After the luncheon, Mr. Vincent Kling, FAIA, founder and senior partner of The Kling Partnership, Philadelphia, Pa., presented the Conference address "Civil Engineering and Architecture: An Inseparable Wedlock." Mr. Kling has been in architectural practice for 40 years and enjoys an international reputation, 'Mr. Kling showed slides which illustrated the structures his firm has designed which have their principal aesthetic in relationship to the structure, not only as the generating force but as the accenting of the visual experience with the structural, Mr. Kling emphasized that it is important that the architecture and the aesthetics of a structure indicate the form of the structural support. The ASCE Student Chapter at the University of Pennsylvania was very honored that Mr. Kling was able to be the Conference speaker.

Following Mr. Kling's presentation, Mr. Sidney Robin, Chairman of Judges, presented the awards for the Student Paper Contest. The following prizes were awarded:

Awardee: Robert L. Rowland, District Engineer, Pa. Dept. of Transportation, Engineering District 6-0, St. David's, Pa. Bob Rowland is responsible for a highway system — in Bucks, Chester, Delaware, Montgomery and Philadelphia Counties consisting of almost 4,000 miles of State Highways and 3,000 bridges. He overseas a staff of more than 1,000 Professional Engineers, designers, construction and maintenance personnel, and an annual budget of \$150 million.

1985 Philadelphia Young Government Engineer of the Year — Presented to a Younger Member employed by Federal, State, Municipal Government or Public Authority, who has contributed substantially to the Civil Engineering profession.

Awardee: Thomas J. Lauer, Assistant Resident Engineer, SW Construction, Phila. Water Dept. Plant Expansion Program. Tom Lauer is currently a Section Director, Chairman of the Student Chapters Committee, and has served as Membershhip Secretary, Associate Member Forum President, and many other special assignments, including Concrete Canoe Races Chairman. Mr. Lauer was Project Engineer and Assistant Resident Engineer for the \$100 million expansion program for the Southwest Water Pollution Control Plant, supervising 15 contractors, 6 inspectors and graduate engineers. Current projects in which he has responsible charge include development of inhouse design and construction; and

Contract Administration and Operation Coordination.

1985 Philadelphia Geotechnical Engineer of the Year — Presented to an individual who is judged to have contributed substantially to Civil Engineering, particularly in the geotechnical area.

Awardee: Dr. Robert M. Koerner, Professor of Civil Engineering, Drexel University. A Past-President of the Philadelphia Section 1975-76, Bob Koerner is the recipient of numerous awards, especially from the Educators' and Researchers' Communities. In addition to teaching, he is actively involved as a Private Consultant in Geotechnical and Foundation Engineering; research for the U.S. Department of Defense, U.S. Environmental Protection Agency, and many other private groups and Public Departments and Bureaus. He is coauthor of textbooks and the author of more than 100 technical papers on Geotextiles, Soil Mechanics, Dam-Failure Detection, Biomedical Engineering, Non-Destructive Testing, Metallurgy, etc. In 1981, Dr. Koerner was elected Delaware Valley Engineer of the Year.

1985 Philadelphia History and Heritage Award — Presented to an individual whose efforts have made contributions to better the knowledge of, or appreciation for, the History and Heritage of Civil Engineering.

Awardee: Sidney Robin, Consulting Engineer and Real Estate Broker. Section Past President Robin (1962-63) has served as History and Heritage Committee Chairman for many years. During his tenure several Philadelphia structures and works have been honored by ASCE as National Historic Civil Engineering Landmarks. These include: (1970) The Frankford Avenue Bridge Over Pennypack Creek - the oldest stone-arch bridge still in active highway use in the United States: (1975) The Philadelphia Municipal Water Supply System and the Center Square Works (originally located at the Site of City Hall) -- the first steam-powered water pumping system in the United States; (1978) The Walnut Lane Memorial Bridge Over The Wissahickon Creek -the first prestressed beam reinforced concrete bridge constructed in the United States.

Among numerous other Phila. Section offices, activities and special assignments, Sid Robin has been Chairman of Publications and Editor of THE

NEWS for more than 40 years. He has chaired the Committee of Judges of the Pa.-Delaware ASCE Student Chapters Annual Conference and Paper Competition since 1963. In private practice, he is actively engaged in Structural Evaluation of real estate properties for Brokers, Mortgage companies, and Federal Housing Agencies; as well as conducting his own real estate and housing design, construction, brokerage and property maintenance practice.


#### Photo Contest Winner

### DOROTHY CARLIN, ENGINEER

Editor's Note: Special thanks to Section Director Sue Lior for bringing this interesting item to the attention of THE NEWS.

Dorothy Allison Carlin, a Philadelphia mative who was one of the nation's first female civil engineers, died recently in Dunn Loring, Va. She was 86.

Born in Philadelphia on Sept. 25, 1898, she attended the city's School of Industrial Arts. She sought to attend the University of Pennsylvania's school of engineering, but was denied admission because she was a woman, said her daughter-in-law, Rosemarie Carlin. Undaunted, she became the seventh woman ever admitted at Cornell University's engineering school and graduated from there in 1924.

In the 1920s and 1930s, she became one of the first women employed as a civil engineer in the nation, and she worked on the first plans for a high-speed commuter rail line between Philadelphia and Camden County. She also worked for the consulting engineering firm of Modjeski, Masters & Chase, and was the first woman ever employed by Philadelphia's city transit department.

In the 1940s, she quit work to raise a son, Alan, while her husband, Phillip H. Carlin, also a civil engineer continued working.

On November 21, 1985 the Portland Cement Association plans co-sponsoring and participating in a roller-compacted concrete (RCC) seminar near the site of the Monksville Dam to be constructed in northern New Jersey.
