AMERICAN SOCIETY OF CIVIL ENGINEERS Philadelphia Section 1987 SALARY and BENEFITS SURVEY

Editor's Note: The Philadelphia Section's gratitude and high praise are extended to President Norman G. Weintraub, who as Employment Conditions Committee Chairman prepared the Salary and Benefits Survey Questionnaire mailed to the Membership with the May-June 1987 issue of THE NEWS. Mr. Weintraub also prepared the following report on the results.

This report is the seventh survey of the Philadelphia Section of the American Society of Civil Engineers. The first report was prepared in March, 1972, the second in the Spring of 1976, the third in the Fall of 1979, the fourth in the Fall of 1981, the fifth in the Summer of 1983 and the sixth in the Summer of 1985. It is expected that the reports will continue to be made bi-annually, with the next questionnaire included with the April, 1989 Newsletter.

Where possible, the following summary also shows the results of the prior surveys.

The results of the seventh bi-annual ASCE, Philadelphia Section Salary and Benefits survey are in. Our typical member is a 35 year old white male and has worked for 13 years. He has gone beyond a Bachelor's Degree, and is either working on or has gotten a Master's Degree, and is a Registered, Professional Engineer. He is salaried, working for a consulting firm doing primarily technical work while supervising three subordinates. This is his second job and he has worked for his current employer 6 years. He earns \$44,000 per year and does not get paid overtime hours. His benefits include 9 days vacation, 10 holidays, 3 days sick leave. Hospitalization and Major Medical are company paid. He does not have company paid dental or optical plans and he contributes to his company disability and pension plan.

As far as trends, there is a five year drop in the median age of respondents (to 35), salaries are up 10%. There were 220 responses this year as compared to 172 in the 1985 survey.



SECTION'S 1987 AWARDS PRESENTED AT SPRING SOCIAL

The Philadelphia Section's annual Civil Engineering Awards were presented during the gala Spring Dinner Dance at Colleen's Restaurant and Towne Hall on June 13, 1987. Six local engineers were honored for their significant contributions and meritorious service to the engineering profession.

Young Engineeer of the Year

David J. Perri. Engineer for the Philadelphia Water Department, was the recipient of the Young Civil Engineer of the Year Award. Mr. Perri, a 1984 graduate of Drexel University was honored for his contributions to the Section and for his professional achievement. He has served as Chairman of the Philadlephia Section's Hospitality Committee, Staff Writer for the award winning THE NEWS, member of the Student Chapter Committee, and as a delegate to the Society's Northeast Regional Younger Member Conference. As the first supervisor of the Water Department's Quality Certification Staff, Mr. Perri has championed the Department's Vendor Surveillance effort from its inception in 1984. His efforts have resulted in significant improvements to the quality of materials manufactured for the City's water and sewer systems. Understanding the importance of commitment to the profession, Mr. Perri has completed continuing education courses at Drexel University and at the Engineers' Club and has become a member of the American Society of Quality Control.

Government Engineer of the Year

Lawrence M. Moy, Chief Highway Engineer for the city of Philadelphia Department of Streets, was honored as Government Engineer of the Year. Mr. Moy directs the Streets Department's Highway Division which is responsible for all construction, maintenance, permit administration and snow removal for over 2,100 miles of roadway and 200 bridge structures. During his seven years as Chief Engineer, Mr. Moy and his staff have implemented a major program of rehabilitation and restoration of the City's highway network. The current rehabilitation of Market Street from 5th Street to City Hall is one of the most challenging and complex projects ever administered by the Highway Division. This project will provide the cornerstone to establish Market Street East as the Champs Elysees of Philadelphia.

The Highway Division with over 500 employees has an annual budget of more than \$38 million. Mr. Moy introduced innovative management techniques to ensure the efficient deployment of available manpower and materials. Despite the many demands placed on his position, Mr. Moy has demonstrated a very professional approach to his duties.

Structural Engineer of the Year

Dr. Frederic Roll, Professor Emeritus at the University of Pennsylvania, was presented with the Technical Award for Structural Engineering. Dr. Roll has been a member of Penn's faculty for over thirty years where he has instructed courses in reinforced and prestressed concrete design. He obtained his Bachelor of Science in Civil Engineering Degree from City College of New York and his Master and Doctorate degrees from Columbia University. After teaching Civil Engineering courses at Columbia, he accepted a faculty position at Ivy League rival Penn in 1957. In addition to teaching and conducting research in Structural Engineering, Dr. Roll is also an eminent Engineering Consultant. As a dedicated member of several Technical Societies, he has served the Philadelphia Section as President, Chairman of the Structural Group, and in many Board and official capacities.

Construction Engineer of the Year

Michael J. Gabor, President and Chief Operating Officer of J.E. Brenneman Co., was the recipient of the Technical Award for Construction Engineering. Mr. Gabor directs the operation of the Foundation Division, specializing in the construction of cofferdams, slurry walls, deep foundations, piles, and earth support systems. He obtained his Bachelor of Science Degree in Civil Engineering from the Pennsylvania State University in 1961. His career began with the Pennsylvania Department of Transportation where he served first as Resident Engineer on several construction projects and then as a Highway Design Engineer. In 1964, he entered private industry when he was hired by J.E. Brenneman Co. to perform engineering duties related to pile driving and waterfront construction. Mr. Gabor left Brenneman in 1972 when he was appointed President of United A & E, Inc. He returned to J.E. Brenneman in 1974 as President and Chief Operating Officer.

Civil Engineering Manager

The Civil Engineering Manager Award was presented to John J. Gillespie, Vice President - Municipal Division of Pennoni Associates. As Division Head, Mr. Gillespie is responsible for managing client services for fourteen townships and boroughs in Bucks, Montgomery, Chester, and Delaware Counties. Projects under his charge have included: preparing the plans and specifications for the demolition of Haverford's 7.6 MGD Sewage Treatment Plant, developing a sanitary sewer manhole inspection program and report for Yeadon, and providing design and administrative services for the reconstruction of Lansdowne's storm water system.

Mr. Gillespie has served as President of the Philadelphia Chapter of the Pennsylvania Society of Professional Engineers, Vice President of the Southeastern Region of the Professional Engineers in Private Practice, and as Chairman of the Delaware Valley Engineers Week Committee. He is a member of several Professional Societies, including the American Public Works Association and the Institute for Municipal Engineering. Mr. Gillespie has also

shared his extensive management and engineering skills with the community as Treasurer of the Mid-County Lion's Club and as a member of the Delaware County Board of View.

Engineer of the Year

The Section's highest award was presented to an individual who has distinguished himself as a creative and resourceful engineer, dedicated to providing the highest quality of service. Moustafa A.
